Motion made by Mrs. DiGirolamo, seconded by Mr. Hartman to accept the results of the Annual Budget Vote and Trustee Election as follows:

WHEREAS, the annual election of the qualified voters of said School District was duly held and conducted on the 19<sup>th</sup> day of May, 2015, for the purpose of voting for a member of the Board of Education and the Budget Proposition contained in the Notice of said annual election, all as more particularly set forth in the sample ballot, marked Exhibit A, annexed hereto and made a part hereof, and

WHEREAS, pursuant to paragraph C of subdivision 7 of Section 2034 of the Education Law, the inspectors of election in each of the election districts have duly made a written report of the results of the ballot at said annual election in each election district, and

WHEREAS, the chief inspector of election of each election district has duly filed such written report with the Clerk of said School District, which reports have been duly present to said Board,

NOW, THEREFORE, BE IT RESOLVED, by the Board of Education of Commack Union Free School District, Commack, New York, as follows:

Section 1. Upon an examination of the reports of the inspectors of election presented to this Board, as described in the preambles hereof, the following is hereby declared to be the result of the ballot at the annual election of the qualified voters of Commack Union Free School District, Commack, New York held on the 19<sup>th</sup> day of May, 2015.
