WHEREAS, the proposed action at Commack High School specifically includes the internal reconstruction of internal classroom(s); and

WHEREAS, pursuant to 6 NYCRR 617.5(c)(1) and (2) of the implementing regulations of the State Environmental Quality Review Act, the "maintenance or repair involving no substantial changes in an existing structure or facility," and "replacement, rehabilitation of a reconstruction of a structure or facility, in kind, on the same site, including upgrading buildings…" are Type II actions;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Education hereby declares itself as the lead agency in connection with the requirements of the State Environmental Quality Review Act; and

BE IT FURTHER RESOLVED, that the Board of Education, as lead agency, after review of the action proposed at Commack High School, 7 NYCRR 617.5, and the opinion provided by ADD

ARCHITECT hereby determines that the proposed action is a Type II Action pursuant to 6 NYCRR 617.5(c)(1) and (2) of the implementing regulations of the State Environmental Quality Review Act, and will, by definition, have no significant adverse impacts on the environment.
