DISTRICT-WIDE EMERGENCY RESPONSE PLAN 2023-2024

District – Wide Emergency Response Plan

Purpose:

- Provide instructions, procedures and guidelines to all for the overall safety of students, staff and visitors in an emergency situation

Scope:

- For all buildings (including auxiliary buildings)
- Each building will prepare a customized emergency plan based from District-Wide plan

Authority:

- District-Wide Incident Commander is Superintendent of Schools (or designee)
- Building Incident Commander is Principal (or designee)
- NYS requires all school districts to have written plan in place and review annually



New Component – Remote Instruction Plan

Purpose:

- to ensure that there is a common understanding about remote instruction amongst district staff, teachers, families, and students.

Scope:

- Show methods by which Commack will ensure the availability of devices, internet access, provision of special education and related services for students with disabilities, and the expectations for time spent in different remote modalities.

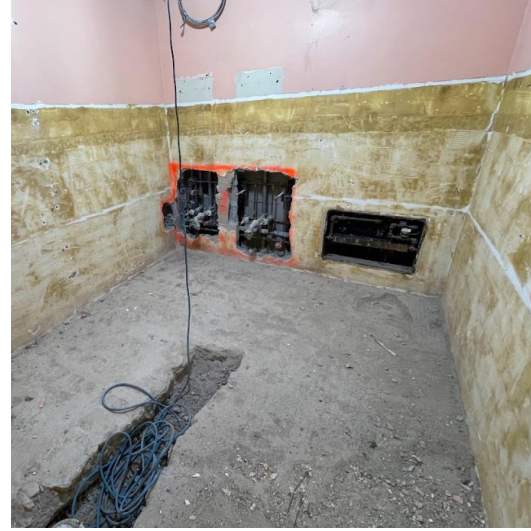

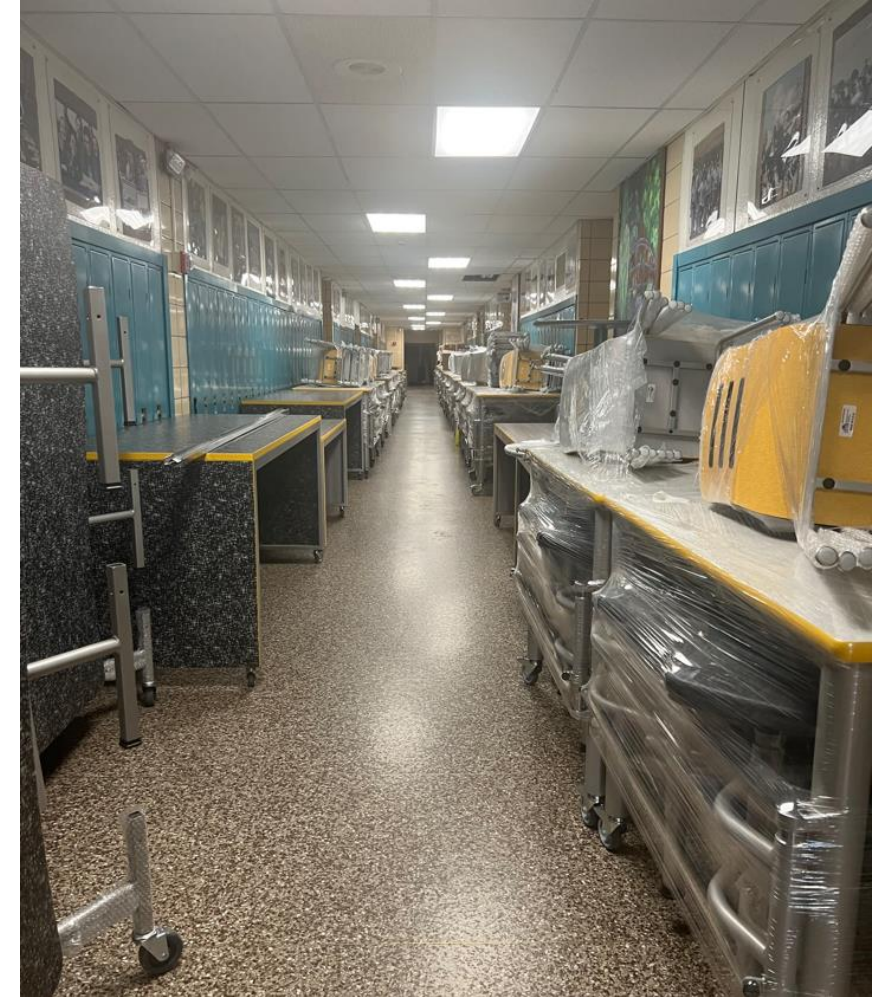

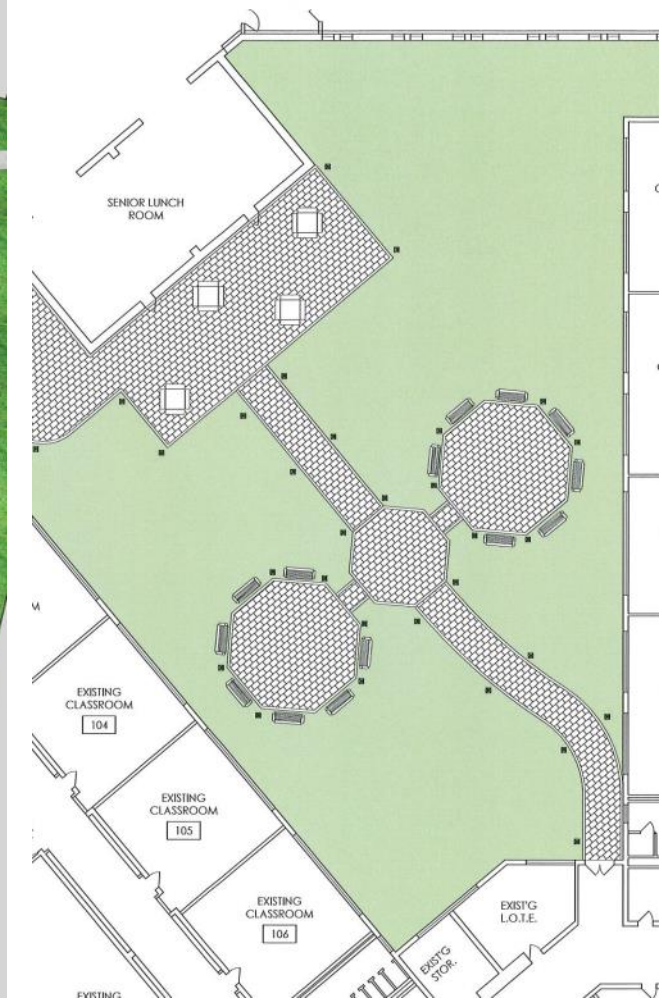

Commack's Policy Review Process:

- A Federal, State, or Local need to review a policy occurs.
- **District Admin.** reviews the policy, and, if necessary, suggests revisions.
- The policy is reviewed by the **BOE Policy Review Committee.**
- The policy is reviewed by **legal.**
- The **Board of Education** is presented with the policy.

Code of Conduct is next

Code of Conduct: Public Hearing

NYSED Commissioner Regulation 100.2 [l] [2] [iii] [a]:

- Each board of education shall **annually review and update as necessary** its code of conduct, taking into consideration the effectiveness of code provisions and the fairness and consistency of its administration.
- A board of education or board of cooperative educational services **may adopt any revision to the code of conduct only after at least one public hearing** that provides for the participation of school personnel, parents, students and any other interested party.

**The Code of Conduct was reviewed and revisions are recommended.
District Administration and Principals were included in the review, as was legal.**

Recommended Revisions to the Code of Conduct

Student Rights

Language added related to DASA and to:

- support a students right to take part in all District activities on an equal basis...
- to be respected as an individual...
- Support a students right to express their opinions...
- To be provided with clear expectation regarding coursework and classroom rules...

Student Responsibilities

Language added related to:

- Support a school community free of violence, etc...
- Support a students responsibility to be truthful with school officials...

Dignity for All Student Act

- Updated listing of Dignity Act Coordinators.
