Dear Twelfth Grade Students and Parents/Guardians:

As the end of the summer nears, the Counseling Center is working to prepare for a productive school year. Please carefully review the accompanying documents that provide essential information regarding the college application process, important dates and events for seniors, and standardized testing information.

Most importantly and to prepare for processing college applications, students will be asked to verify their transcript. All family's need to verify their child's transcript, with particular attention to the June 2021 English Language Arts Regents score. An electronic survey was sent to all parents/guardians via the Infinite Campus Parent Portal and students were able to choose a numerical score <u>or</u> an "E" for Exemption to be listed on their transcript. Students will be given an updated transcript from their school counselor during class meetings in early September.

The Counseling Center will be offering our College Application Summer Camp this year in late August. This group program will allow students to be guided by a member of the counseling staff to learn more about the application process and continue working on the Common Application. Information has been included in this mailing as a reminder. In the event that your child is unable to attend our College Application Summer Camp, please pay special attention to the information provided about setting up a Common Application account and signing the FERPA Release Authorization Form, as well as completing the Common Application Account Matching process in Naviance. The Counseling Center website has videos explaining all of these steps. Additionally, information is included on our College Essay Writing Workshop, hosted by college admissions officers. **Students must register in Naviance to attend these workshops.**

The College Application Help Desk will resume this fall, to provide on-the-spot assistance to students, in addition to individual counselor meetings. Students can ask questions about the various application platforms, application processing procedures, the submission of testing scores and more. Detailed information regarding program days and hours has been posted to our website.

Students will also have the opportunity to meet with their counselor during a Class Meeting scheduled for Monday, September 13th and on either September 22nd or September 23rd. More information will be shared with students upon return to school. Lastly, Senior College Night is scheduled for both parents/guardians and students on September 21st at 7:00pm.

Thank you for your cooperation and attention to this information. I hope you enjoy the remainder of your summer and have a successful senior year!

IMPORTANT INFORMATION AND DATES FOR SENIORS 2021-2022

COLLEGE APPLICATIONS

The Counseling Center will submit our portion of your applications electronically through Naviance. For us to do so, students must complete the following steps:

- Have an active Naviance Student account. Naviance Student can be accessed through the High School Counseling website (http://www.commack.k12.ny.us/CounselingCenter.aspx) by selecting the College Planning tab then the Naviance tab on the left side of the page. If you have forgotten your username or password, please contact the Counseling Center.
- 2. **Create an account with <u>www.commonapp.org</u>**. This account is required to submit applications electronically through Naviance, for colleges who utilize the Common Application.
- 3. Complete the FERPA Release Authorization on the Common Application. The FERPA question is found within the "Assign Recommenders" tab of the application and the "release authorization" link must be checked with the FERPA decision. Students can only see the "Assign Recommenders" tab once (at least) one college is added to the account. Watch the video on the Counseling Center website to be guided through this process.
- 4. **Complete the Common Application Account Matching Process.** Once logged in to Naviance, select the "Colleges" tab, then "Colleges I'm Applying To." The Common Application Account Matching screen is displayed at the top of the page.

Students must complete the **COMMACK HIGH SCHOOL COLLEGE APPLICATION PROCESSING REQUEST GOOGLE FORM.** The counselor will review the application, complete the secondary school report, and attach the appropriate materials before submitting. It is important that an **updated Activity Resume** and **two teacher Letters of Recommendation** be on file with us. Teacher letters, a copy of the official transcript and, if required, a counselor letter of recommendation, are sent with each application.

It takes us approximately four (4) weeks to process and submit application materials from the time students submit them. Therefore, please be aware of your colleges' deadlines as well as our processing deadlines in the Counseling Center to ensure that your applications are submitted in sufficient time for us to complete our responsibilities. IF YOU ARE APPLYING FOR EITHER EARLY ACTION OR EARLY DECISION, BE SURE TO INDICATE THE DATE THE APPLICATION IS DUE TO THE COLLEGE ON THE PROCESSING REQUEST FORM. Additionally, since many schools have a rolling admissions policy (the first applications received are the first considered), you should file applications as soon as possible. IT IS IMPORTANT TO NOTE THAT ALL APPLICATIONS WILL BE PROCESSED IN THE ORDER THEY ARE RECEIVED AND APPLICATIONS WILL NOT BE PASSED OVER TO MEET THE DEADLINE OF A LATE APPLICATION. ALL COLLEGE APPLICATIONS RECEIVED ON OR BEFORE NOVEMBER 15 WILL BE PROCESSED AND SENT NO LATER THAN JANUARY 1.

ON-SITE ADMISSION OPPORTUNITIES

Commack High School will continue to offer onsite admissions opportunities for many of the colleges in our local area. This option allows students to meet directly with admissions representatives from these schools and often receive immediate decisions regarding their application. More specific information regarding the dates and times of these visits, as well as registration information, will be available on the Counseling Center website, through morning announcements, and in the Counseling Center.

TESTING INFORMATION

Your college application is not complete until you send your official scores from the SAT and ACT to the college of your choice. You can do this simply by logging on to your College Board or ACT student accounts. Students have the option of selecting which SAT and ACT scores they wish to submit to colleges. Please know that there is a fee to send scores, and scores must be received before the college application deadline.

FINANCIAL AID AND SCHOLARSHIP INFORMATION

The cost of post-secondary education is a major element involved in the final choice of a school. To help you with this aspect, we will provide you with as much financial aid and scholarship information as possible. We distribute **Scholarship Bulletins** through email notifications, make PA announcements regularly and post scholarship information on the bulletin board outside the Counseling Center, as well as on the Counseling Center website. All scholarship applications requiring official records must be processed through the Counseling Center so that we can attach the appropriate materials, ensure the mailing is submitted and issue a receipt. **SCHOLARSHIP APPLICATIONS will be accepted every day and require ten (10) days for processing.**

<u>Please note that the filing process for financial aid has changed.</u> Students will be able to file a 2022-23 FAFSA (Free Application for Federal Student Aid) as early as **October 1, 2021**.
